### **Election of Directors**

All nomination materials **must be received no later than two business days prior to the date set for the AGM, or Monday, June 22nd 2015, at 5:00 p.m.** Any candidates for the Board nominated by this process will stand for election for any vacancies remaining on the Board after the election of the slate.

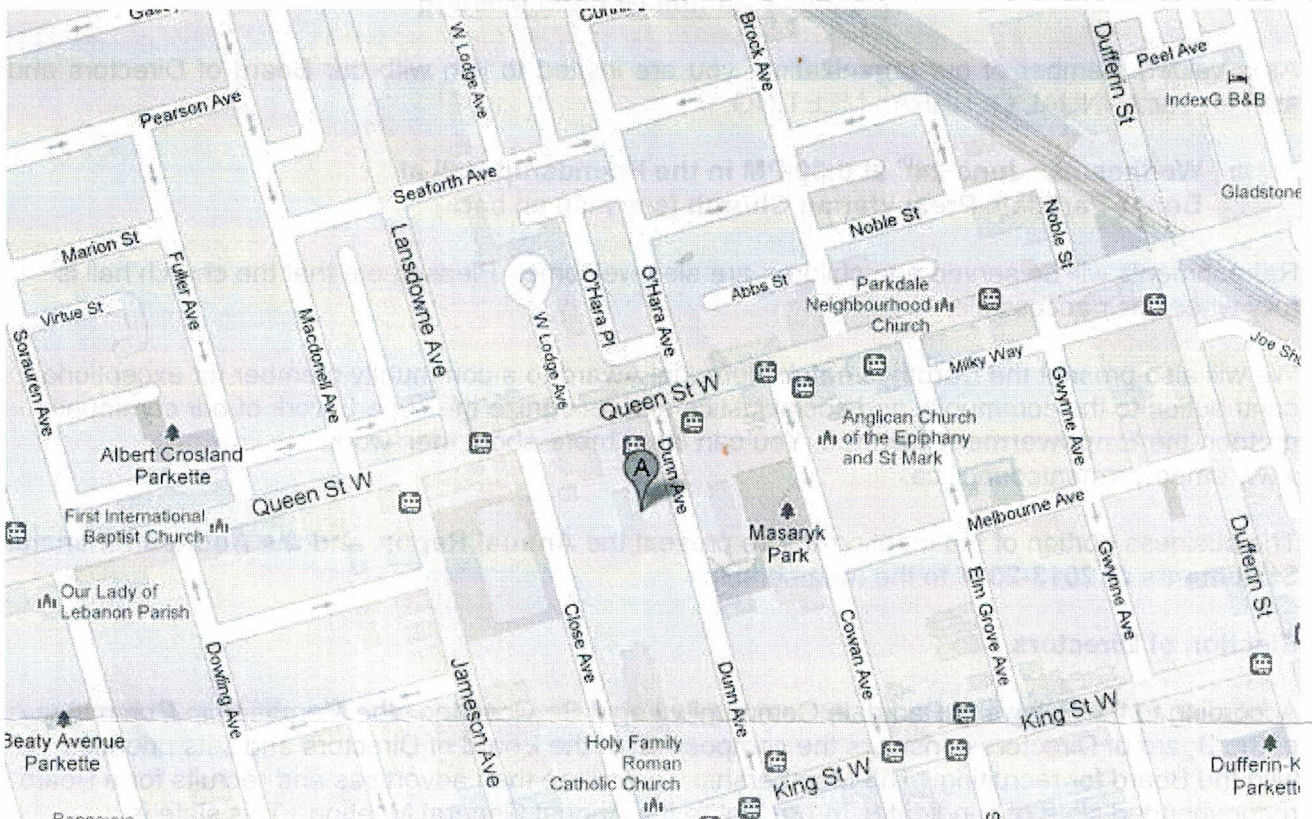
